THE EXECUTIVE DIRECTOR

These are challenging times. This has been a year of uncertainty for thousands across Texas-and across America. From rising costs of living and unemployment, to the floods and the fires, it can feel like the ground beneath us shifts a little every day. At TLSC, we feel these uncertainties around our funding. Government and Foundation priorities have changed-jeopardizing many of the grants we rely on to fund our mission. Much of this is beyond our control. One foundation informed us that they plan to focus their efforts on Canada moving forward. This year we learned funding for our Housing and Impact Litigation programs, some of our Medical Legal Partnership funding, and almost half of our Crime Victims funding program is no longer available to us. These challenges will be felt most significantly by our clients, who desperately need our help. Last year, we answered 18,000 calls from people who were facing eviction. Without dedicated funding, we will try to help as many as we can-but no doubt many will be turned away.

There are many unknowns, but we will rise to the challenge and pivot when we find new opportunities to further our mission when it aligns with our funders' changing priorities. We have already taken this opportunity to grow our Veterans and Child Welfare programs—which are stronger than they have ever been!

We continue to boldly harness technology and innovation to maximize our resources for access to justice. In the short term, that means more clients receive help more quickly. In spite of our losses, I'm proud to share that—as the only generalist, statewide, legal aid organization-we are reaching Texans in rural areas that have no other legal options and we are streamlining our intake processes to reach even more. We've taken legal aid directly into the communities we serve, planting 45 TexasLawHelp.org legal kiosks around the state. Through the kiosk-and popular TexasLawHelp.org website-we're connecting Texans to legal help faster than ever, and responding directly to the communities' needs, creating local landing pages with local resources for sites who host the kiosks in their local libraries, shelters, community centers, and court houses. Additionally, we've created tools like Texas Family Help Link to streamline intake for families in child welfare cases. And we will use the website to launch the training program for new volunteers in the Community Justice Worker project—where we are collaborating with other legal aid programs like Disability Rights Texas, Texas Rio Grande Legal Aid, Lone Star Legal Aid, and Legal Aid of Northwest Texas—to multiply our efforts to meet our clients' needs.

We are working to modernize our intake system to serve our clients better and create efficiencies that will make the most of our limited resources. We're building this new intake system with clients and referral partners at the center of our design. I envision this technology serving as the foundation for a coordinated effort to create a seamless client experience—ending the frustration of bouncing referrals from one legal aid organization to the next and back again—saving vulnerable Texans and legal aid partners' precious time.

As you look through the impact TLSC made on thousands of Texans this past year, know that these are more than numbers. It is proof that together we provide the stability that makes recovery possible. With the help of a strong community behind us, we will weather the storms that come our way and continue fighting for a more just Texas.

Through TexasLawHelp.org and other programs, we empower Texans with education about the legal system and processes to make informed choices about how to seek justice.

ADVICE

We provide quick legal advice through phone and chat services to guide clients on their legal issue.

REPRESENTATION

Our attorneys represent clients with the same commitment and skill as private attorneys, often achieving superior results. Our team handles cases with professionalism and care, ensuring clients receive the legal support they need.

LEGAL PROBLEMS ADDRESSED AT THE LEGAL COUNSEL AND ADVICE LEVEL OR ABOVE

When Texans were not eligible for our services, we shared resources that could help them over **7,200 times.**

215 TEXAS COUNTIES SERVED

TLSC is the only legal aid organization serving Texans statewide. This year, we reached Texans in **86% of all Texas counties.**

60% of these counties were in **rural areas**, often with limited or nonexistent access to legal services.

By investing in innovation, we're strengthening our mission. Streamlining complex processes and building tools that meet people where they are helps us deliver help faster and expand access to justice for tens of thousands of Texans.

LEADING LEGAL ACCESS INTO THE FUTURE



AUTOMATING ELIGIBILITY SCREENING

We overhauled our screening process for callers and online applications to provide a better experience for our clients. Reducing manual processes frees our staff to help more Texans. Portions of this new system released this year, and the final phase completes next year.

EMPOWERING NEIGHBORS TO HELP NEIGHBORS

Led by Disability Rights Texas, the **Community Justice Worker Program** expands access to legal services for lowincome Texans using trained lay advocates to provide limited-scope civil legal services. We developed an online training portal to certify Community Justice Workers, our piece in this collaborative effort with five other Texas legal aid organizations. The project launches in January 2026.

FASTER HELP FOR TEXAS CHILDREN AND FAMILIES

Early this year, **Texas Family Help Link**, a project with TLSC's Family Helpline, debuted on TexasLawHelp.org. In one application, families and children match with TLSC or other Texas legal aid organizations to get to the help they need more quickly. This tool reduces a time-consuming, frustrating cycle we have heard from many clients: filling out multiple applications, repeating their stories, and waiting weeks for answers.

LEGAL KIOSK EXPANSION

Our TexasLawHelp.org Legal Kiosk Program is evolving into one of the most promising access to justice innovations in Texas. What began during the pandemic as a lifeline for people without internet or devices has grown into a community-centered gateway to legal aid. Today, kiosks sit in libraries, homeless shelters, and other community hubs, meeting Texans where they are and giving them the tools, guidance, and confidence to understand and exercise their rights. Looking ahead, the network is poised to become an even more powerful statewide resource, integrating legal needs assessment, intake, guided legal forms, and new technology that will help more Texans resolve life-changing legal problems with dignity and clarity.

ADVANCING FEATURES ON TEXASLAWHELP.ORG

TLSC attorneys and staff power
TexasLawHelp.org, the largest free
legal resource for self-represented
Texans to find plain language guides and
articles for their civil legal issues along
with court-ready forms. Last year, we
brought language access to the forefront
with continuous translation for both
Spanish and Vietnamese.

This year brought two new features:

Amigo, an A.I. bot built from the site's content, launched to help Texans find the resources they need when attorneys are offline—like a digital librarian.

Next, Lone Star Legal Aid assisted us with adding Legal Aid Content Intelligence (LACI) software to the site. LACI tracks changes in laws and regulations, helping our team update content quickly so Texans can rely on timely, accurate guidance.



Amigo provided legal resources to visitors 26,000 times since January 2025.

EXPANDING OUR REACH

TLSC FILM NIGHTS

TLSC Film Night is a fundraiser and film series exploring themes of justice and the importance of doing the right thing. We began this series to raise awareness about TLSC and access to justice.

Over 80 attendees packed the theater during the premiere at Amplify Austin Day in Austin featuring To Kill a Mockingbird. We partnered with San Antonio Legal Services Association (SALSA) and SALawHelp for the San Antonio event with Legally Blonde in September. Themed cocktails and an inspiring talk from 2024 Austin Woman Magazine's "Woman to Watch", Leah Wise along with support from St. Mary's Law School and San Antonio Young Lawyers Association created a night to remember. Finally, we culminated the year honoring Texas Veterans for Texas Veterans Legal Aid Week in November featuring A Few Good Men. Lieutenant General Gwen Bingham regaled life lessons from her military experience and emphasized the critical nature of legal services for veterans.

EVICTION HELPLINE

I am a family law judge in Fort Bend County. One-third to one-half of our cases each day are self-represented litigants; most of whom are using legal forms provided through TexasLawHelp.org. We regularly refer these parties to the Virtual Kiosk [now named Legal Kiosk] located in the law library in the courthouse where they can get legal questions answered if they have issues in their case that are preventing the case from moving forward. We have gotten a lot of positive feedback from the parties who have followed up with the referral. Our county does not have many resources for low-income parties who need free legal representation or advice.

In most of these self-represented cases, the parties just need a little help or legal advice and then they are able to complete the case on their own. The virtual kiosk helps fill that gap
